FAA Registration

At this month's meeting there was a discussion about FAA registration and remote aircraft ID. These are actually two separate items and it seems that now would be a good time to review them both for the benefit of new members, as well as those of us who have been around a while.

First, anyone operating an rc model that weighs more than 0.55 lbs (250 grams) - be it an airplane, helicopter, or multicopter - needs to have an FAA registration number displayed on the model. You can register for an ID number at faadronezone-access.faa.gov.

Second is the issue of what is referred to as Remote ID. This is basically having a transponder onboard the model so that it can be tracked by an FAA facility. But here is the important part for us. If you are flying at an FAA Recognized Identification Area (a FRIA) you do not need Remote ID. The good news here is that our club field is an approved FRIA. So, if you are flying at our field you will need to have your FAA registration number displayed on your model, but you do not need Remote ID. Again, models under 0.55 lbs (250 grams) are exempt from the remote ID requirement.

Another important point involves The Recreational UAS Safety Test (TRUST). If asked by law enforcement you need to be able to show your TRUST certificate and your FAA Registration

certificate. You can take the TRUST test at trust.modelaircraft.org. It is a very simple test that covers the appropriate regulations as well as some safety information.

The FAA drone zone site contains more detailed explanations of the points described above. It may seem like a lot of red tape and hoops to jump through, but the process is very straightforward and rather simple. In recent years there have been incidents involving collisions of full scale aircraft with drones. These regulations were designed to help reduce the possibilities of such collisions and were created as a result of Congressional requirements placed on the FAA. AMA played a strong role in seeing that the impact of these regulations would be minimal for clubs such as ours.

It may seem like a bit of overkill for our site since we are pretty far out in the country and not too near any airports. But I think that we have all seen examples of medevac or law enforcement helicopters flying over our field, so an encounter with a full scale aircraft is a possibility even at our field.

FMS Orders
