This month's column is a little different than my usual one. The topic this month is safety – or do as I say, not as I did. On Friday June 22, 2012, I was at Mac Hodges' field practicing for an SPA event. As I have done many times before, I was starting my Dirty Birdy. But this time I didn't have a starting stand, nor did I have someone holding the plane (mistake 1). After starting the engine I went to remove the glo plug clip. But the whirling knife, aka APC prop, intercepted my left thumb (mistake 2). The result was not pretty. Fortunately, a nurse was there to help me wrap the thumb and my wife drove me to the Americus Hospital. Eleven stitches later I was able to return to the field and retrieve my equipment. Now it gets interesting. We had come to the contest

to fly and I felt ok, so the real question was whether I could work the left stick without using my thumb, which was encased in a large bandage and a splint.



After some experimentation, I found that I could work the left stick by holding it between my first and second fingers. So, I put in three more practice flights before heading to the pharmacy to pick up my prescription for some pain pills. I was able to fly the four rounds on Saturday and two on Sunday without too much trouble. I'll admit that the rudder inputs on my point rolls were a bit off, but I was able to fly and ended up winning my class. The pictures pretty much speak for themselves, especially the close-up of my thumb without the bandage. So, be careful out there. And remember to treat the prop with respect!
